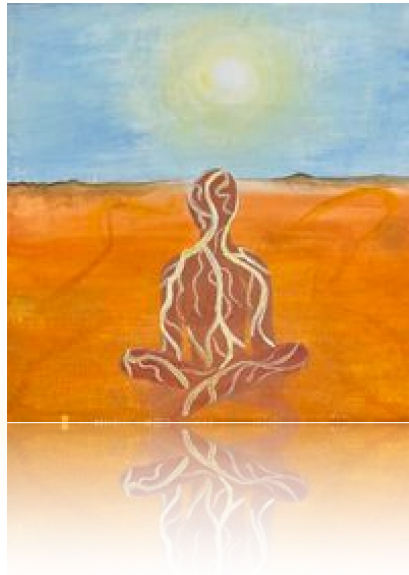

106.This family is targeted. Harassed. Tormented, Tortured, disenfranchised, disrespected, set up for a fall.

107.When Terrence was arrested, he was a tormented man having had his 2 boys taken away by failure of Lawful Due Process. For a second time.

108.The DCP wrote an unsubstantiated claim about the family, presented it in the Bunbury Magistrates Court, without the the knowledge of Terrence or Cheyenne and via Magistrate Tyers acquired a Protection Order for themselves.

109.Police then attended the school and terrorised families by taking the children.

110. The Common Law Sheriffs attended the school and advised families, it was not Lawful behaviour. Many sighed relief. Others said they were planning to remove their children.
111. The School Principal said if he did not do what he was told, he would be in a lot of trouble.
112. In 2023 the Common Law Sheriffs returned the boys to Terrence and Cheyenne after holding accountability to all Departments.
113. They returned for 9 months after being suddenly kidnapped again by DCP, supported by Police.
114. Naturally the distress of Terrence and Cheyenne was beyond measure. Any normal individual can empathise with that.
115. But these are not normal individuals in these government departments. There is a lot of gloating and joy at watching agony unfold.
116. As no supporting paperwork was made available via DCP, in his frustration at the kidnap of his children, Terrence broke the window at the DCP office.
117. Instead of this natural expression being understood, it is used as a weapon to incarcerate and apply many other charges to the list.
118. All of which require a claimant in the court and evidence, or the charges should be dropped and Terrence let go. Immediately.
119. Baby Olivia is absent from her family. Kidnapped by the State at 5 weeks old, and given to some other family.
120. The kidnap was attempted at birth from Bunbury Hospital, but Common Law Sheriffs intercepted that. Someone was determined to snatch that baby girl.
121. The circumstances this family endure through are Crimes Against Humanity.
122. Certainly we are watching today to see what happens.
123. Full accountability to Lawful Due Process must be adhered to.
124. Please be mindful of previous Orders by the Terra Australis Grand Jury.

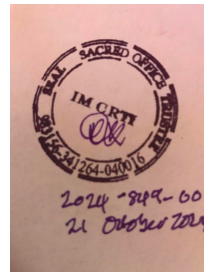
